Sub: Formation of panel for the post of SM in ML-6 against 15% LDCE quota, in Optg.Dept, Mumbai Division.

As per Amendment to Para 122 of IREM – Provision regarding filling up of post of Station Masters against 15% LDCE quota, issued vide Bd's letter No.E(NG)I-2016/PM1/12 dt.16/02/18 as under:

“15% by Limited Departmental Competitive Examination (LDCE) from amongst staff working in Operating and Commercial Department in ML-1 to ML-5 with an upper age limit of 45 years (50 years in case of SC/ST) and qualification of Graduation subject to the condition that staff in ML-1 have rendered a minimum of 05 years regular Railway Service”.

Therefore, it is proposed to hold a selection to form a panel of 48 vacancies for the post of Station Master (SM) in ML-6 against 15% LDCE quota.

The community break up of 15% LDCE Quota vacancies is as follows :

GL – 42, SC-04 ST -02 Total – 48

In terms of Rly.Bd's letter No.E(NG)1.97/PM2/8 dt.25/07/02, the posts of SM in ML-6 against 15% LDCE quota are to be filled in through General Selection for which the following are the conditions to be fulfilled for eligibility.

15% by Limited Departmental Competitive Examination (LDCE) from amongst staff working in Operating and Commercial Department in ML-1 to ML-5 with an upper age limit of 45 years (50 years in case of SC/ST) and qualification of Graduation subject to the condition that staff in ML-1 have rendered a minimum of 05 years regular Railway Service”.

Applications are, therefore, invited from Operating & Commercial staff in ML-1 to ML-5, who are Graduate and below 45 years (50 years in case of SC/ST) as on 07/01/2026.

In terms of Bd's letter No.E(NG)1.2025.PM1/3.dt.26/05/25, selection will be judged by examination to Computer Based Test (CBT) . Those who qualifying in the CBT, directed for the medical examination in class “Aye Two “ for the post of SM in ML-6. Those who passed the medical examination will be directed for in appearing psychological test. The panel will be formed strictly on merit as per Bd's letter No. dt.19/06/09. The selected candidates will have to undergo training at ZRTI BSL.

Since, the above is a General selection, the benefit of reckoning of 30% pay element for the purpose of fixation of pay of running staff is not admissible as per Rly Bd's letter No.E(P&A)II/2022/RS-2 dt.20/02/23 (RBE No.34/2023).

Paper pattern :

As per Rly Bd's letter dt.14/12/2018 (RBE No.196/2018), 100% objective papers for promotion of staff within Group-C by selection or non selection & Group-D to C selection has been introduced. All the questions will be of multiple choice only. There shall be negative marking for incorrect answers and one third of the marks allotted for each question will be deducted for wrong answers.

Syllabus :

The syllabus for CBT exam for the above selection is enclosed.

Railway Recruitment Cell, Central Railway (RRC/CR) will issue formal admit card online through the official website of Central Railway.

The schedule of Pre Selection Training (PPT) of eligible SC/ST candidates and date, venue & timing of Computer Based Test (CBT) will be informed later. The eligible candidates should be in readiness for both i.e. PPT & CBT at short notice.

Submission of applications:

The candidates who fulfil the above all conditions should submit their applications in their own handwriting in the prescribed Proforma-A through their Depot-In-Charges. Last date of submission of application to Depot / Station is on or before 17/01/2026. The depot in charges will forward all applications to this office in a lot on or before 20/01/2026.

Please notify to the staff concerned and submit their application strictly in a lot addressed to APO(T)BB by name, so as to reach this office not later than 17-00 Hrs. on 20/01/2026. Applications received after this date will not be accepted.

This should be given wide publicity.
